Friable and Non Friable Asbestos:

- Delivery by Certified Asbestos Contractor, hired Waste Transporter, or by homeowner from residential property of four units or less
- Full load manifest required including designation of Friable or Nonfriable
- Packaged and wetted in six mill bags or double bagged in three mill bags, or in fiber drums – all labeled. Example-Menards
- For demolition projects or bulk waste can be wetted and burrito wrapped with prior approval
- Delivery directed to area designated for Friable Asbestos with landfill employee present
- **By appointment only in good weather so we can handle it properly and must be delivered and out of here by 3:00PM – We prefer a 24 hour notice.**
- Slate or Transit type siding or shingles are considered friable by Iowa rule.
- \$75.00 per ton tipping fee
- **Payment by cash, credit card or local check with each load. May leave signed check “open” to pay for all loads that day. This applies also to companies with accounts already established with the landfill.**

For longer projects may establish a “credit forward account” by completing an authorization form providing business and contact information, authorized users, and depositing cash in the account prior to delivery.

Load manifest will include:

- Description and quantity of material including designation of Friable or Nonfriable
- Address where material is coming from
- Signature of owner and/or certified asbestos contractor from site of origination
- Name, address, and signature of waste transporter
- Telephone numbers for Owner, Operator, and Transporter
- Our signature and load verification.
